How do I open and manage my account?	<p>Opening your account:</p> <ul style="list-style-type: none"> You must: <ul style="list-style-type: none"> be a UK resident. be aged 18 or over. Provide your National Insurance number deposit a minimum of £500 You can also open the account by transferring funds from another ISA provider. With Beehive Money, if you want to transfer your ISA savings from the current or previous tax year, you must transfer the full balance. Partial transfers are not permitted. Accounts can only be in your name. Joint accounts are not permitted. <p>Managing your account:</p> <ul style="list-style-type: none"> You can manage your account via Beehive Money. Once this product has been withdrawn, you won't be able to pay any more money into your account. You can pay in your total ISA allowance each tax year (which is £20,000 for the current tax year). Whilst the product is available, you can pay any amount into your account, up to the annual ISA allowance. You can pay money into your account by simply sending us an electronic payment from your nominated account. Our Faster Payment sort code is: 60-95-93. Once you have opened your account this sort code should be used with the eight-digit account number for all Faster Payments, BACS and standing orders. You will not be able to send payments via CHAPS. You can only fund one Beehive Money cash ISA in each tax year. You can also make unlimited transfers of previous ISA subscriptions up to £250,000. With Beehive Money, if you want to transfer your ISA savings from the current or previous tax year, you must transfer the full balance. Partial transfers are not permitted. If you transfer money from a previous year's ISA, it won't affect your ISA allowance for the current tax year. 		
Can I withdraw money?	<ul style="list-style-type: none"> You can't make any withdrawals or close the account during the fixed rate period. You can transfer funds in full or in part to another ISA. You must transfer current tax year savings in full from us. There will be a charge of 90 days' interest on the amount transferred. This means you might get back less than you originally deposited. The transfer of ISAs from one provider to another should be completed within 15 days (or up to 30 days for a transfer of a stocks and shares ISA to cash ISA). Shortly before your fixed rate period ends, we will send you details of how you can reinvest your savings with us or take out some or all of your money. If we do not hear from you, we will transfer your balance to a variable easy access ISA. You will continue to earn tax-free interest. Depending on how you choose to reinvest your savings, these will be available from 01/08/2025 		
Additional information	<ul style="list-style-type: none"> If you change your mind after you've opened your account, don't worry. You can withdraw from or close your account within 14 days of the date you have funded the account. Other accounts are available with Beehive Money and other providers, subject to withdrawal conditions you can switch to these at any point. 		



We will pay your ISA free of UK income tax. The tax treatment of ISAs may also change. AER stands for Annual Equivalent Rate. It shows what the interest rate would be if the interest was re-invested in the account each year.

Protecting your money

The Financial Services Compensation Scheme (FSCS) is there to protect your money if your financial services provider goes out of business; you'll normally get your money back within seven days.
